You can apply for a Tier 2 (Health and Care) visa if: you have a job offer from the NHS, an organisation providing medical services to the NHS or an organisation providing adult social care you ' re...

Make and keep copies of all documents. You can apply for a Tier 4 (General) visa up to 3 months before the start of your course as stated on your CAS. The Home Office MAY invite you for an interview or call you to check you are a genuine student. Failure to attend the interview will likely lead to your application being refused.

If your visa application is delayed. This advice applies to England Print You might be able to find out why your immigration application is delayed by contacting the Home Office, or your local MP. You might want to make sure your passport will be returned in time for a holiday, or simply be worried about how long the decision is taking.

If your visa application is delayed - Citizens Advice

You can currently only apply for a National Insurance number in England, Scotland and Wales if you have entered the UK on a visa. You cannot apply for a National Insurance number in Northern Ireland.

If you wish to study in the UK you will need to apply for a Tier 4 visa under the PBS (points based system). As with all tiers there are sub-tiers. Each sub-tier has different criteria, you must make sure that you apply for the correct visa based on your circumstances. Tier 4 General Student Visa
